3


Gradually reduce emissions from business travel by 90% by 2045.

Emissions reduction targets

To achieve Net Zero, and in line with the Science Based Targets initiative SBTi, we have adopted the following carbon reduction targets:

- We are committing to reduce our Scope 1& 2 emissions by at least 45% by 2030 and 90% by 2040.
- We are committing to reduce our Scope 3 emissions by at least 30% by 2030 and 90% by 2045.
